Bhagavad-Gita as a Stress Management Guide - Cont.

Chapter Four:

Bhagavad Gita is like a 700 piece jigsaw puzzle without its original box. You don't know what the puzzle is supposed to look like. Many pieces look alike and many appear very complex. You don't know where to begin. There is one jigsaw piece, however, that is the key to understanding *Gita*: And that is *Gita*: 3:42). Once you understand this piece thoroughly, the whole of *Gita* becomes a piece of *Mithai woondo*. In our chapter two, we saw the model of the mind as three concentric rings: *Atman*, *Buddhi* and *Mana*. Five gates (Senses) connect the outermost ring (Mind) to several little circles (Sense Objects). The model I am presenting below is the same model except that you are now looking at it from the front, like looking at a Christmas tree.

Conflict with others is a major source of stress in our daily life. Every conflict between two people has to do with one side wanting to possess what the other side has, or to control it. This results in one side wanting to impose its will, view, opinion or belief on the other. We see this in every conflict in the world: between husband and wife; between parents and children; between in-laws; between friends; between boss and employee; between business partners; between communities, and even between nations. Evil behavior from one side or both follows. So Arjuna asks Lord Krishna: *Gita* 3:36: "What is it that drives a man to commit evil, Varshneya, however reluctantly, as though propelled by force?"

Lord Krishna reply is powerful: *Gita*: 3: 37-39: "It is selfish Desire (*kama*), it is anger (*krodha*), which springs from the force of passion (*Rajas guNa*, one of three *guNas* which we will study later) the great devourer, the great evil; know that this is the enemy here. Just as the fire is covered by smoke and mirror is obscured by dust, just as embryo is covered by amniotic membrane, Knowledge (Intellect) becomes covered by this selfish Desire- hidden, Arjuna, by this unquenchable fire for self gratification, the inveterate enemy of the wise." Wow!

Gita: 3: 40, 41: "The Senses, the Mind and Intellect (Zones 4, 3 and 2) are the sitting places of this selfish Desire, which clouds the real knowledge (*Dharmajnana*) of individuals and bewilders them. Therefore, Arjuna, in the very beginning itself curb selfish Desire, the great symbol of sin, by controlling your Senses, and then kill off that evil which destroys insight and Knowledge."

Gita: 2: 62, 63: "While contemplating the objects of senses (People, money, power, etc.) a person develops (excessive) attachment for them, and from such attachment selfish desire develops, and from it arises anger (perhaps out of frustration). From anger arises delusion (grandiosity, paranoia), and from delusion bewilderment of memory (cognitive functions deteriorate). When memory is bewildered, intelligence (wisdom) is lost (we begin to make stupid mistakes). When this happens, one falls into degradation (one becomes totally stressed-out)."

Here Lord Krishna is not referring to our plain human desire to live, love, be loved, eat, sleep, clothe and have fun. The kind of selfish Desire he is referring to is like the blind ambition Duryodhana had. Let us see if we can relate these to examples of excessive attachment to sense objects in our daily lives:

1. Excessive attachment to people: A mother (who reads *Gita* every day) excessively attached to, and possessive of, her son creates tension between her son and daughter-in-law. She does her best to prevent her son from spending any time with his wife. Her controlling behavior drives a wedge between him and his wife. The son (who knows *Gita* by heart) being excessively attached to his mother is gutless in standing up to his mother for fear of losing her affection. His *dharmajnana* (what is right and what is wrong) becomes clouded by his possessive love for his mother. He silently watches his wife being mercilessly tortured by his mother. Likewise, a person possessively attached to a friend becomes jealous and angry when his/her friend associates with another person.

The tragic consequences of excessive attachment can be seen everywhere in Mahabharata: Bheeshma's excessive attachment to his father, Shantanu; Shanthanu's amorous attachment to Satyawati; Dhritrashtra's sick attachment to Duryodhana, etc. Cultivating an attitude of "Let go and let God" changes everything for the better.


2. Excessive attachment to money leads to Money Disease. In this malady, a person is obsessed with making and accumulating money even when he does not spend it usefully. It is as useless or dangerous as excess fat in the body. His every thought, every utterance, every behavior, every action, every human contact, every friendship, membership of every "service organization" is geared toward the ulterior motive of making money by hook or by crook. He misses no opportunity to use people to profit from them. Every one of these people lives a miserable life as he never knows the pleasure of giving, of contentment, or of peace of mind. His obsession with money kills his *dharmajnana*, humanity or divinity. You must read *Gita*: 16: 12-18 at this point: The corrupt bureaucrats and politicians and some businessmen you meet in India are classic examples of these people. Inevitably, greed leads to fraud, and fraud leads to financial, legal and family problems. Unfortunately, their children and grandchildren end up suffering from their *karmaphala*. Unlimited availability of illicit money leads to bad habits and self-destructive behavior. Cultivating an attitude of "contentment, fairness, generosity, charity" etc. (*Gita*: 16: 1-3) will liberate this person from the bondage of money disease.

3. Excessive attachment to power, position, title, etc. leads to dirty politics and power struggle we see in every organization, be it a political party, temple committee or a cultural association. People with this affliction simply keep hankering for power, position, title, status, etc (*Thaggele pashi hodu jana haanva*). They hang on to it until they get kicked out unceremoniously by someone more powerful than he. Apparently they have never heard Kenny Roger's song "You've got to know when to hold it, know when to fold it, know when to walk away and know when to run.....! An attitude of "selfless service" (*Nishkama karma*) liberates one from this whirlpool of misery. *Gita*: 2: 47-51. 5: 10.

4. Excessive attachment to food, sex, drugs, alcohol, sex, gambling: Stressed-out people use these as a way to calming themselves down. Overeating leads to obesity, heart disease, diabetes, arthritis. Drinking excessively leads to alcoholism, liver, stomach and heart disease. Likewise, gambling, taking drugs, illicit sex, etc. have serious long term consequences. Financial, legal health and family problems follow as day follows night. Cultivating an attitude of "moderation in everything" and regulating one's daily habits (*Gita*: 6: 16, 17). (Remember the saying?: *Khellale aash chadi, nahllaleka chikkol chadu!*)

5. Excessive attachment to material things (*Gita*: 5: 22) such as house, cars, gold, jewelry, gadgets, etc. could lead to severe stress for fear of one day not having these, or for fear of others having more of these. Pathological jealousy is common. More often than not people use these things as a way of promoting their image in others' eyes ("prestige issue") rather than for any true self-enjoyment. These people begin to define their lives by what others think of them, not what they think of themselves. The affliction of "comparing and competing" (C & C disease) is a major source of stress among some Indians in America. One can cultivate an attitude of enjoying material comforts in a detached manner (*Gita*: 5: 8,9). Cultivating a simple attitude such as "I am happy for him that he has all these things and that these things make him happy!" would liberate one from the misery of jealousy. Another liberating attitude is "What anybody thinks about me or my financial situation makes no difference to me."

A brief history of Kolakere Prabhus

Bolanthur house of Prabhus

Bolanthur is a village adjacent to kolakere House. It belongs to the Mogranadu 1000 seemas. Bunts (a community of non brahmins occupying first place in Tulu Nadu) were land lords in this area. They were connected with other Bunt Guthu Houses. Ira is a place adjacent to Manjeshwara where the Royal Daivas (spirits) Kuriadhaya belonging to a major Guthu House. Every year the Kiruvala (belongings like sword, face plate, bell etc.,) of Daiva Kuruiadhaya is coming in procession to Bolanthur and annual festivals are taking place.

These Guthu Houses of Bunts community once faced some conflicts. All the festivals and programs were compulsorily to be attended by the deputies of these group of Bunt families/houses . Due to conflict, some of them were not attending and subsequently confrontation or feud developed. Every year, during the Nema of Daivas, fights used to take place. In one of the Nemas, the Daiva Kuriadhaya gave a ruling that Kolakere Prabhus are popular for their honesty, justice and truth. Whatever judgment given by Kolakere Prabhus must be accepted by all. The Nema was abruptly wound up and postponed to some other day. All parties came to Kolakere House and requested Govinda Prabhu-II who was the Head of Kolakere House. He heard all the parties and gave his judgment. The revise date for the Nema was fixed and Kolakere Govinda Prabhu-II attended as per the wishes of Daiva Kuriadhaya. In the Nema all the parties of dispute agreed to abide by the judgment of Govinda Prabhu-II. For solving the problem and to unite the Guthu Houses, Daiva Kuriadhaya gifted some lands to Govinda Prabhu-II. All the families agreed with the Daiva's decision. The Daiva also directed that they are pleased to have Kolakere Prabhus to be amidst them. These gifted field is called as *inamastil*. Kadambi santhaya Prabhu (Venkatesh Prabhu) who was responsible for Kadambi Guthu had two sons. The elder Govinda Prabhu-III was asked to come over to Bolanthur and a Guthu House was started. His younger brother Narayan Prabhu-II remained in Kadambi.

Subsequently, Bolanthur House was given a status of House of Adoption i.e. whenever there are no male children in Kolakere and Kadambi, the adoption is from Bolanthur House.

Every year the Kiruvala of Daiva Kuriadhaya is arriving from Ira and 3 days Nema festival takes place in Bolanthur. One Nema is to be attended by Bolanthur Prabhus compulsorily.

Kadabikars gifts

Kadabikars gifts to Kashi Mutt:

Our elder Dharmanista Pradhan Kadambi Manjajya Prabhu has created an un-parallel history among the Gowda Saraswat Bhramins which can be seen from an unusual incident popularly known as *Manjajya Prabhu's Daana Shasana Deed*.

Kadambi Prabhus are popularly known as a *Dharmista* Family. Many kinds of offerings, charity flew from this house of Gowda Saraswat Bhramins of this area. So also from our Kolakere House.

Sri Kashi Mutt head office in the Dakshina Kannada District was in Bantwal to look after the landed properties, revenues, viniyogas etc. This Mutt's day to day affairs were vested on a small group of landlords who were nominated by the Guru to discharge their duties on a honorary basis. It was a privilege in those days to become the Trustee of the Kashi Mutt Trust. The trustees were responsible for collecting the revenue from the lands belonging to the Mutt. Kadambi House Prabhus were responsible for Vittal, Adynadks, Perla etc., areas near the Kerala border.

It so happened that there were successive calamitical problems like drought, epidemic diseases like small pox, measles etc. as a result the farmers/tenents were unable to deliver the rents in the form of rice. These aggrieved farmers fell on the feet of Manjajya Prabhu

who had waived their rentals. Kadambi House was holding nearly 2000 murras of rice earning property. Hence, Manjappa Prabhu thought it is not difficult for him to reimburse the unpaid revenue.

Over the years, once in a meeting the committee of trustees of Kashi Mutt found that nearly 600 murras of rice was due from Kadambi House account. Hence, Manjappa Prabhu himself advised the committee to give him legal notice as they do it for defaulting tenants.

The case continues. Manjappa Prabhu admits that 600 murras of rice is due to Kashi Mutt and obtains a decree to that effect.

It was the time in 1885. His Holiness Srimad Bhuvanendra Thirth swamiji was the Pontiff, who arrived to Bantwal in his usual visits. Kadambi Manjappa Prabhu reaches Bantwal and met the Guru. Next day he conducted the "Bhiksha and Padapooja" to the swamiji. It is during this time, a devotee gets darshan with Guru and could communicate his wishes to the Guru. Manjappa Prabhu asks for a favour and Guru agrees unconditionally. Manjappa Prabhu offers a document packed in a silk cloth and presents it to the Guru along with the fruit offerings. In the night, Manjappa Prabhu asks the Guru to permit him to leave early in the morning to Kadambi.

In the night, the manager of the Mutt gives a daily report to Guru as a custom. In that there was a document called as "Daana Shasana- Gift Deed" dated 6-6-1885. It offers a large property which fetches 600 murras of rice to the Mutt every year. The Guru was shocked to hear the same and tears rolled down in his eyes for the devotion of *Dharma Veera* like Manjappa Prabhu. Guru calls other trustees and the entire story of initiating a legal proceedings against Manjappa Prabhu was inferred. Guru was annoyed and chided them for challenging a man like Manjappa Prabhu. A message was sent to Manjappa Prabhu not to leave for Kadambi unless meeting the Guru.

Next day morning after the prayers/pooja, Manjappa Prabhu meets the Guru without aides. Guru tells Manjappa Prabhu to take back the document and that the Mutt does not require property but very honest and god-loving devotees. Manjappa Prabhu pleads the Guru with folded hands and tears carried in eyes to accept the property as per the word given by the Guru on the previous day. Manjappa Prabhu says that his family members should not be blamed by anyone that they have cheated the Mutt by not giving the rents. Actually, it was a honorary duty to the Mutt. We should not carry the debts of the Guru Mutt. The Guru was immensely pleased for the courage and unshaken faith of Manjappa Prabhu whose ethical/moral levels no one has ever touched.

There was a special relation of Bhakti of Manjappa Prabhu to the Guru and special love from Guru to Manjappa Prabhu. It was there for a long time even before the Kadambi Property was gifted.

Guru tells in one occasion to Manjappa Prabhu that Kadambi House is like a large banyan tree under the shadow of which many people, animals, birds live happily. Such a house need a large property to conduct the charity for many. Manjappa Prabhu says that the Guru is like a *Kamadhenu* which gives a everything that is demanded under the sun. So, Manjappa Prabhu says that it is worth to give Kalpavriksha and get the Kamadhenu whose blessing is like the flowing milk. Guru was invited to Kadambi to stay for 3 days. A special function was organised to gift the property and to take blessings from Guru. But the mystery took it's own course. The day the Guru left the house of Kadambi, the fall of the house begun. The Goddess Laxmi left the house. Difficulties started in the family both financial and social relations.

One day when the Guru was in Varanasi (Banaras) or Kashi, as usual after the noon pooja, devotees are given Thirth-Prasad. A man from Bantwal came there to receive the blessings of the Guru. Guru had the habit of asking the questions like from where he comes from, to which family he belongs etc. The Guru was eager to ask about Manjappa Prabhu's welfare. That man has told in low voice that Manjappa Prabhu has departed. The swamiji was so much sad, His Holiness rose from the seat and went straight to the river Ganga. Dipped in water, looking at Sun, carrying water in hand, he said, " Oh! Vyasa Raghupathi Deva, give Sadgati (liberation of soul) to the Dharmista Manjappa Prabhu.

In the very next year on the same day (thithi) and on the same month Guru Bhuvanendra swamiji attains Bhramaikya (Moksha). This even indicates the Shishya and Guru reaching a common axis of love and honour to each other.

The lesson for every Kadambikar is that don't expect anybody else's favour. Give more and don't expect to get anything from others. Don't be in the debts of God and Guru. For the pending of 600 murras of rice which he could had given with least pain, he donated a vast property which gives to the Mutt every year 600 murras of rice.

Gift to Gokarna Mutt:

Kolakere House faced unfortunate events almost from 1900. The last head of the House was one Narasayya Prabhu. Within few years of his departure, his only son Kolkere Vaikunta Prabhu (popularly known as Bale Prabhu i.e. Child Prabhu) met with a fatal death in the hands of his maternal uncle. The story goes as follows.

Kolakere House was owning vast landed property right from Panemangalore bridge upto Maani in Puttur road and upto Veer Kambha on Vittla road commanding 6000 murras of rice property as revenue/rent. Vaikunta Prabhu's maternal uncle was in Kolakere House

as Accounts manager to look-after the property and to maintain accounts. Vaikunta Prabhu was a minor and his widow mother Kolakere Bhagirathamma had no major role to play, the maternal uncle Kolakere Vittappa Shanbogue administered poison to Vaikunta Prabhu. He died on Gowri Puja day (previous day to Ganesh Chaturthi) and since then the Gowri Puja stopped in Kolakere House as a mark of sadness. Vaikunta Prabhu was a handsome boy, well built, fair in colour and above all, very kind and humane in his deeds. The Management fell in the hands of Smt. Bhagirathi Narasayya Prabhu and her brother Vittappa Shanbogue. There were two fatal blows of sorrow on Bhagirathi-amma due to the successive deaths of her husband and lonely darling son. She went into Vairagya (dissillusion) as a result, the Management became the absolute asset of Vittappa Shanbogue.

The Gokarna Parthgali Jeevotham Swamiji Srimad Indirakanth Thirth arrived in Mangalore where they have a Mutt in Car street. Vittappa Shanbogue was having his house near Car Street met the Guru along with Bhagirathamma who explained her frustration. The Guru was kind enough to hear the entire affair and gave "Mantra Akshatha" to Bhagirathamma to get her released from "Putra Shoka" (sorrow of a departed son). After an year or so, Bhagirathamma felt much relief.

In the next visit of the Guru to Mangalore, Vittappa Shanbogue and Bhagirathamma met the Guru. In gratitude of which Bhagirathamma donated 100 soverigns of Gold coins on a silver plate and presented the same. With that money, the frontage of the Mangalore mutt of Gokarn mutt was built.

In 1913, Kolakere Bhagirathamma passed away in Mangalore. Her death was another mystery. Her brother who was titled as Kolakere Vittappa Shanbogue prepared a document of "Adoption" of his son Narayana Shanbogue as a successor to Kolakere House. The rule to adoption is to take either from Bolanthur or Kadambi and not outsider. The end of Bhagirathamma was the end of Kolakere Prabhu family. During the period of vacuum of Management, the Kadambi Prabhu family senior members Upendra Prabhu and Ramakrishna Prabhu came to Kolakere and took over the Management.

The "Adoption Deed" was set aside by the district court and Vittappa Shanbogue had to leave Kolkere House. Later he sued the Kolakere House for the debts raised by Bhagirathamma which was a false case. Since no much evidence was given to defeat the case, 3000 murrachs of rice land was sold and money was paid among Gowda Saraswat Bhramin families, she had gold coins stored in a large copper vessel known as "Kopparige" having 7 rings tied with chain to the ceiling (Sat Kana Kopparige). Was there a need for her to borrow from her brother who was a manager?. There were some forged promisory notes having thumb marks of Kolakere Bhagirathamma, the debt remained valid.

Thus, the present Kolakerekars are no other than Kadambikars. Kolakerekars is a fundamental name for Kadambikars because our moolapursh (founding father) is Kolakere Govinda Prabhu.

Gift to Canara High School:

In the year 1908, the management of Canara High School Mangalore under it's founder President Ammembal Subraya Pai decided to construct a Hostel for out-station GSB students. In those days the contributions collected were routed through the local temples like Manjeshwar Anantheshwara Temple, Mangalore Venkataramana Temple, Moolky Narasimha Temple etc. Individual donors granting higher sums were few.

Kolakere Bhagirathy Narasiah Prabhu granted 100 soverigns of Gold coins. She was the highest donor among individual donors. Her intention was to perform always right things. She also granted 42 murrachs rice property (one Korji) to Manjeshwara Temple for a permanent pooja on Palgun Panchami. Also she made arrangement for permanent Nanda Deep in the Manjeshwara Temple. Besides, she had made innumerable contributions to various temples and institutions. In those days, people used to remember her as " KOLAKERE PARBUNI " who was an emblem for Charity.

Devoted to Kashi Mutt and Gokarna Mutt,

Devoted to Kuladevatha and Manedevuru Kolakere Narasimha Devaru...

Liberal in donations for Satkarma.

High respect for his family and traditions.

Commands respect from the society and GSB circles.

Remembers Satya, Nyaya, Dharma and Paropakara.

Possesses an attitude to help individual and to bring him up even at his own cost.

"Word of Honour" maintained at any cost.

Sympathetical to those who seeks his help. Prepared to do anything for those who seek asylum.

" Welfare Thinking " of others. He gives less importance to self and his own family- "Paropakari".
